

# Kardinaal Alfrink Peace Fund 2018

## Report activities 2018

1. In 2018, the Peace Prize was given to the No Boundaries Coalition of Baltimore, Maryland (USA). The No Boundaries Coalition was formed as a non-profit organisation in 2010 after three years of block parties had connected several diverse West Baltimore neighbourhoods and enhanced resident engagement. The organisation's primary priorities are public safety and access to healthy food; it also hosts listening and accountability fora for public officials and organises voter registration drives. No Boundaries was chosen because of their courageous work in confronting ongoing systemic racism, economic exclusion and civic disconnection, transforming their vulnerable community through nonviolent approaches into viable and secure living spaces for all, across the boundaries of race, class and neighbourhood.
2. With regard to the peace prize 2019, it was agreed to propose to the international board the following candidates:
  - European Lawyers In Lesvos (ELIL) who do incredibly good work and have just been cut back on their funding because Oxfam can no longer support the network. They help people a step further in the dramatically-poorly organized procedures, with insufficient funding. <https://www.europeanlawyersinlesvos.eu/>
  - Movement on the ground : <https://movementontheground.com/> because of the concrete assistance provided to refugees in the Greek islands over the past two years.
  - Campaign for access to asylum: <http://asylum-campaign.blogspot.com/> Old advocacy group formed by local and local Greek lawyers who try to advocate in favour of the deficiencies of the Greek asylum procedures.
  - <http://www.bxlrefugees.be/nl/>: La 'Plateforme Citoyenne de Soutien aux Réfugiés' wants to build concrete solidarity with all migrants. It denounces current Belgian and European migration policies and recalls that the right to live in dignity belongs to all.
  - European Council of Religious Leaders (created by Card Danneels and Patriarch Kirill and the former Norwegian Archbishop of Lutheran church in Oslo). The European Council of Religious Leaders (ECRL) brings together senior religious leaders from Europe's historical religions: Judaism, Christianity and Islam together with Buddhists, Hindus, Sikhs and Zoroastrians. <https://ecrl.eu/>
  - The European Network on Religion and Belief ENORB strives to provide a civil society platform of different religions, beliefs and convictions to facilitate dialogue and promote the rights and freedoms enshrined in the EU Charter on Fundamental Rights and in other international human rights conventions.   - Northern Ireland. In connection with the Brexit, the dialogue there between the churches is again very relevant and important. In 1999 we awarded the prize to "The Clonard

Fitzroy Fellowship: from Northern Ireland, for their Catholic-Presbyterian initiative to unite people in a divided community". Suggestion is to ask our members in the United Kingdom and Ireland and our relations in Northern Ireland to look for candidates for the prize who are currently working to maintain and strengthen peace in Northern Ireland through inter-religious dialogue.
