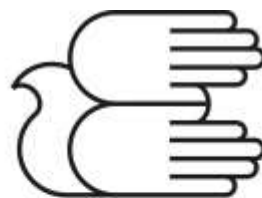

# Overview of the Main Proposals

## Survol des Principales Propositions

**1. Improving the effectiveness of UN Security Council resolutions** by introducing measures like banning arms sales to non-compliant states

**2. Enhancing UN Secretary-General and UN General Assembly's Roles** to avoid UN Security Council blockages

*(e.g.: allow UNSG to seize UNGA if UNSC deadlock)*

# Overview of the Main Proposals

## Survol des Principales Propositions

### 3. Limit the VETO Right: Enlarging Article 27 UN Charter Scope to issues related to international peace and security

#### Article 27

1. Each member of the Security Council shall have one vote.
2. [...]
3. Decisions of the Security Council on all other matters shall be made by an affirmative vote of nine members including the [...] permanent members; provided that, in decisions under Chapter VI, and under paragraph 3 of Article 52, a party to a dispute shall abstain from voting.

#### Chapter VI: Pacific Settlement of Disputes

#### Chapter VII: Action with Respect to Threats to the Peace, Breaches of the Peace, and Acts of Aggression

OUR PROPOSAL: “... in decisions under **Chapters VI and VII**, and under paragraph 3 of Article 52, a party to a dispute shall abstain from voting”
